1. GENERAL INSTRUCTIONS

1.1. *The text layout*

Texts should be written on A4 pages. The margins for A4 pages are: top: 4.4 cm; bottom: 4.99 cm; left: 3.47 cm; right: 3.47 cm; margin for binding: 0.00; header: 0.8 cm; footer: 3.25 cm.

1.2. *The type and size of font; interlines*

The paper's title should be written in Times New Roman, size 15. The paper itself should be written in Times New Roman, size 10 with a single interline. The titles of the paper's main sections should be written in capital letters. The headings of subparagraphs should be written in italics. Please do not use bold type or underline.

2. FIGURES

2.1. *The quality of figures; captions*

Figures included in the text should be black-and-white with the best possible resolution (min. 300 DPI). Captions should be written in Times New Roman, size 9.

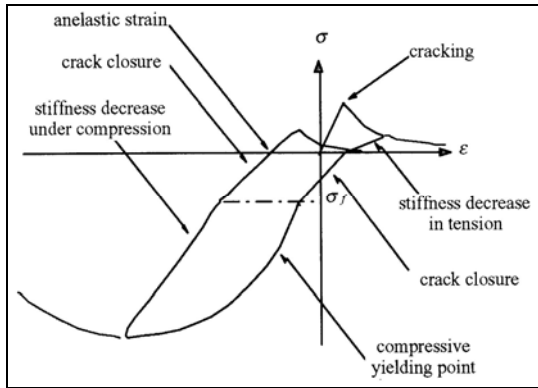


Figure 1. Typical caption of a figure

3. TABLES

The titles of tables, just like figure captions, should be written in Times New Roman, size 9. The content should be written in Times New Roman, size 9 or smaller.

4. FORMULAE

Formulae should be written using an equation editor.

Below is an example of an equation with its description:

$$K_t = \left(1 - \frac{R^2 \tau}{c_\alpha + v \tan \delta} \right)^4 k_1 \quad (1)$$

where: c_α – interface adhesion; δ – friction angle at interface; and k_1 – shear stiffness number.

5. LITERATURE

The literature quoted in the text should be properly marked with a number in square brackets which would refer to the list of literature at the end of the article. The list of literature should be written in Times New Roman, size 9.
